MedicineInsight GP Snapshot Chronic Obstructive Pulmonary Disease

Insights from the national MedicineInsight Program show how COPD management compares with aspects of the COPD Clinical Care Standard. Participating practices will receive a report based on their practice data in early 2025.

MEDICINEINSIGHT DATA - PATIENTS OVER 35 YEARS

SPIROMETRY

An estimated **39,000** patients diagnosed

with COPD



25% of patients with COPD currently smoke compared to 9% of all patients

Around **1 1 2 IN 5 1 1 1** patients with COPD had a spirometry test

Practice point: COPD cannot be accurately diagnosed based on clinical features or chest x-ray alone.

Conduct spirometry for:

- Patients over 35 with symptoms and at least one COPD risk factor
- Patients diagnosed with COPD who have not had a test before.

INFLUENZA VACCINATION

83% of patients with COPD have received an influenza vaccination **Practice point:** Offer all patients with COPD an annual influenza vaccination.

- Consider other vaccinations including pneumococcal disease
- Also check vaccinations according to their medical history, age and the Australian Immunisation Handbook.

SMOKING STATUS AND CESSATION ADVICE

96% of patients with COPD had their smoking status recorded

61% of patients with COPD who smoke were recorded to have been offered smoking cessation advice

Practice point: Update your patients' smoking status at least annually.

The most effective way to manage smoking cessation is through a combination of strategies including:

- Behavioural support and counselling (e.g., referral to Quitline)
- Pharmacotherapy (e.g., nicotine replacement therapy, bupropion or varenicline).¹

- Healthcare Variation Focus Report The upcoming interactive COPD Report from the Commission's Atlas of Healthcare Variation series will analyse national datasets, including Medicare and PBS. This report will compare spirometry testing and medication management by geographical area. While MedicineInsight looks at individual clinical care patterns, the Atlas data will reveal how care changes over time and across different regions. It will also discuss data discrepancies, challenges to achieving the best care, and possible solutions.
- The COPD Clinical Care Standard Released in October 2024, outlines the main care components that all Australians with COPD should receive. It comprises ten quality statements focused on diagnosis, comprehensive assessment, education and self-management, vaccination and smoking cessation, pulmonary rehabilitation, pharmacological management, oxygen and ventilatory support during exacerbations, followup care after hospitalisation, and symptom support and palliative care.
